**ORDER INDEFINITELY  
TRANSFERRING PETITIONER TO  
DISABILITY INACTIVE STATUS**

**FILED SEPTEMBER 29, 2016**

On July 19, 2016, Harry P. Friedlander (Petitioner), by his attorney Karen Clark, Adams & Clark, PC, filed a Petition for Transfer to Disability Inactive Status. By Order of the Presiding Disciplinary Judge (PDJ) filed on July 25, 2016, Petitioner was temporarily transferred to disability inactive status and the underlying discipline matter PDJ 2016-9036 (State Bar File No. 15-2494) was stayed pending a hearing on Petitioner's competency to assist in his defense under Rule 63(c)(4)(B), Ariz. R. Sup. Ct. Under Supreme Court Rule 63(a), the parties were strongly encouraged to submit a consent agreement.

On September 19, 2016, the parties filed a Consent Agreement to Transfer to Disability Inactive Status (Agreement). Accordingly,

**IT IS ORDERED** accepting the Agreement.

**IT IS ORDERED** pursuant to Rule 63(b)(3), Ariz. R. Sup. Ct., that Petitioner **Harry P. Friedlander** is incapacitated and unable to discharge duties to clients, the bar, the courts or the public, and is indefinitely transferred to disability inactive status effective the date of this order.

**IT IS FURTHER ORDERED** Mr. Friedlander lacks the competency at this time to assist in his defense pursuant to Rule 63(b)(4), Ariz. R. Sup. Ct.

**IT IS FURTHER ORDERED** good cause appearing and pursuant to Rule 63(d)(1), Ariz. R. Sup. Ct., the disciplinary proceedings in PDJ 2016-9036 (State Bar File No. 15-2494) are stayed pending further order of the Court.

**IT IS FURTHER ORDERED** pursuant to Rule 72, Ariz. R. Sup. Ct., Mr. Friedlander shall immediately comply with the requirements relating to notification of clients and others.

**IT IS FURTHER ORDERED** proceedings and records relating to transfers to and from disability in active status are confidential, except for orders of transfer pursuant to rule 63(e), Ariz. R. Sup. Ct.

**IT IS FURTHER ORDERED** vacating all pending deadlines and hearing dates.
