

STATEWIDE LIST OF COURT APPOINTED INVESTIGATORS

In compliance with Rule 10(F), Arizona Rules of Probate Procedure, the following individuals have completed the court investigator training and have been issued a certificate of completion. Effective September 1, 2012, individuals must complete this training and file a copy of the certificate with the appointing court before they can be appointed to a case as a court appointed investigator.

The list identifies the county of residence of each investigator. Once an individual has completed the required training and meets the requirements of Arizona Revised Statutes §§ 14-5303(C), 14-5407(B) and 36-540(G); and Rule 10(F), Arizona Rules of Probate Procedure they are eligible for court appointment in any county. A number of investigators serve in more than one county or serve in a county different than their county of residence.
