On November 4, 2015, this Court entered Administrative Order No. 2015-89, establishing the Pretrial Services Committee (“the Committee”) and Administrative Order No. 2017-128 extending the term of membership to end December 31, 2019. The Committee continues to address pretrial services and evidence-based practices related to measuring risk and determining appropriate release conditions as well as advancing the use of pretrial risk assessment in limited jurisdiction courts, thus the individuals appointed as members should be reappointed for an additional 2-year term. Robert W. Johnson, Probation Services Supervisor, Superior Court in Yuma County, has advised that he is no longer able to serve on the Committee.

In accordance with Administrative Order No. 2015-89, the Chief Justice may appoint additional members to the Pretrial Services Committee as may be necessary.

Therefore, pursuant to Article VI, Section 3, of the Arizona Constitution, and after due consideration,

IT IS ORDERED reappointing the individuals listed in Appendix A as members of the Committee beginning upon entry of this Order and ending December 31, 2021.
