Administrative Order No. 2018-52 was entered on June 8, 2018. The Order established the Post-Conviction Actions Task Force to consider proposed amendments to statute and rule relating to the setting aside of criminal convictions, restoration of civil rights, and the setting aside and disposition of records of juvenile adjudications.

The Task Force continues to examine issues that may result in proposed legislation, rule change petitions, and revisions to forms, that will be considered by the Arizona Judicial Council in December 2019.

Therefore, pursuant to Article VI, Section 3, of the Arizona Constitution,

IT IS ORDERED that Administrative Order No. 2018-52 be amended to extend the term of the Post-Conviction Actions Task Force to December 31, 2019.

IT IS FURTHER ORDERED that the term of service for the appointed members, in Appendix A, of the Post-Convictions Actions Task Forces be extended to December 31, 2019.
