PRO TEMPORE ORDER  
No. 2012 - 38

The presiding judge of the Superior Court of Arizona in Pinal County has requested the appointment of judges pro tempore to assist that court with the processing of cases. Therefore, pursuant to Ariz. Const. Art. VI, § 31 and A.R.S. § 12-141 et seq.,

IT IS ORDERED that the persons named in Appendix A attached hereto are appointed judges pro tempore to serve the Superior Court in Pinal County for terms beginning July 1, 2012, and ending June 30, 2013.

IT IS FURTHER ORDERED that the persons named in Appendix A shall perform judicial duties authorized by A.R.S. § 12-144 as assigned by the presiding judge. This appointment is conditioned upon the approval of the Pinal County Board of Supervisors pursuant to A.R.S. § 12-141, and upon the Superior Court in Pinal County obtaining appropriate funding from whatever source for any compensation due to said appointees pursuant to A.R.S. § 12-142(C) and A.R.S. § 12-143 for service as judges pro tempore.

IT IS FURTHER ORDERED that the persons named in Appendix A may perform duties of a judge authorized by A.R.S. § 25-121 et seq. and A.R.S. § 12-2222 without specific assignment by the presiding judge subject to agreement by the appointee to perform these duties without public compensation or benefits.
