PRO TEMPORE ORDER  
No. 2013 - 18

The presiding judge of the Superior Court of Arizona in Maricopa County has requested the appointment of court commissioners to serve as judges pro tempore to assist that court with the processing of cases. Therefore, pursuant to Ariz. Const. Art. VI, § 31 and A.R.S. § 12-141 et seq.,

IT IS ORDERED that the persons named in Appendix A are appointed judges pro tempore to serve the Superior Court in Maricopa County for terms beginning July 1, 2013, and ending June 30, 2014.

IT IS FURTHER ORDERED that the appointees shall perform judicial duties authorized by A.R.S. § 12-144 as assigned by the presiding judge. These appointments are conditioned upon the approval of the Maricopa County Board of Supervisors pursuant to A.R.S. § 12-141, and upon the agreement by the appointees to serve without compensation or benefits, other than that to which they are entitled as Superior Court Commissioners, as provided in A.R.S. § 12-142(C) and A.R.S. § 12-143 for service as judges pro tempore.

IT IS FURTHER ORDERED that the appointees may perform duties of a judge authorized by A.R.S. § 25-121 et seq. and A.R.S. § 12-2222 without specific assignment by the presiding judge and subject to agreement by the appointees to perform these duties without public compensation or benefits.
