

Important: Please read carefully before proceeding:

All applicants must complete and provide evidence as required. The Supreme Court has deemed each one of these criteria as required. Submission of application without these requirements will result in denial of certification to sit for the examination.

Gather all supporting documentation prior to completing your online application. The exam application must be complete at the time of submission.

You are required to advise the Committee of all changes to your Application and/or Character Report occurring from the time of filing until your date of admission.

General Requirements for Admission by Uniform Bar Examination:

Applicant is or over the age of 21 years.

Applicant is of good moral character.

Applicant is mentally, emotionally and physically able to engage in the practice of law, and possesses the required knowledge of the law.

Applicant holds a Juris Doctor degree from a law school approved by the American Bar Association (ABA) at the time of graduation.

If you do not hold a Juris Doctor from an ABA approved law school, you must have been actively engaged in the practice of law in some other U.S. state or states for at least three of the past five years prior to filing an application of admission by examination.

Required Documentation to be Certified to sit for Uniform Bar Examination:

The below documentation must be provided to the Committee on Examinations in order to complete processing of your application. You will be prompted to attach/upload some of these documents where applicable in this online application. Otherwise, you must directly mail the supporting documentation after submitting your online application.

1) The examination and application fee, as established by the Court. (*Online payment is required at time of application*).

2) **Fingerprint Card** - (standard FBI blue and white card, on heavy stock, ink or digital live scan prints only). Cards are available from law enforcement agencies or the Committee on Character and Fitness [Request Fingerprint Card](#);

3) **Photo** - Passport-type photograph of you only; head neck and shoulder, no hat, hoodie or other item obstructing your head or face; minimum 2" x 2"; maximum 2.5 x 2.5 inches. Polaroid photographs and paper prints are **UNACCEPTABLE**. Color or black/white photograph is acceptable. Write your name and social security number on the back of the photo.

4) **Evidence of Graduation** with a Juris Doctor degree from an ABA-approved law school. (See question 20 for documentation requirements).

5) **Certificate(s) of Good Standing** - Must provide if previously admitted to practice law in any jurisdiction, foreign or domestic, a certificate of the appropriate court agency or the mandatory bar association, whichever has custody of the role of attorneys in that jurisdiction. The certificate must indicate the date of admission, and that the applicant is presently in good standing, the applicant resigned in good standing in that jurisdiction, or is capable of achieving good standing.

6) Documentation proving citizenship or immigration status (see Question 14 and 15 for documentation requirements)

Documentation Required Prior to Admission to the Practice of Law

1) **Valid MPRE Score** - acceptable minimum scaled score of 85, taken within 2 years before the successful bar examination or within the time frame for taking the oath of admission (Supreme Court Rule 35(b)(8)). Applicant must submit proof of a valid score on the Multistate Professional Responsibility Examination (MPRE). 2) **Proof of completion of Arizona Law Course** For registration information on how to fulfill this requirement, please go to the following link, where you will find information allowing you to either view video modules, from your computer in any location, or register for a class to be administered in Arizona. 3) **Character Report Application** - (Separate Application) Not required to be filed with your exam application. Applicant can be certified to sit for the bar examination without having filed the Character Report application.
