Administrative Order No. 2009-47 was entered on July 1, 2009. The Order adopted Section 6-311, Detention Standards in the Administrative Code of Judicial Administration, Part 6 Chapter 3 § 6-311(D)(1) which states:

The administrative director shall establish a detention operations standards advisory committee. The committee shall consist of seven members appointed by the administrative director. The committee shall meet as needed to advise the administrative director concerning changes in the detention operations standards. The majority of the members shall constitute a quorum.

Administrative Directive No. 2016-03 re-established the Juvenile Detention Operations Standards Advisory Committee on March 7, 2016. Membership terms were for two years and expired on July 31, 2017.

Therefore, pursuant to ACJA § 6-311(D)(1),

IT IS DIRECTED that the Juvenile Detention Operations Standards Advisory Committee is re-authorized as follows:

1. **Purpose:** The Juvenile Detention Operations Standards Advisory Committee shall convene as deemed necessary by the Administrative Office of the Courts.
2. **Membership:** The individuals listed in Appendix A are appointed as members of the Committee effective upon signature of this order and ending on July 31, 2020.
3. **Meetings:** Committee meetings shall be scheduled at the discretion of the Chair of the Committee.
4. **Staff:** The Administrative Office of the Courts, Juvenile Justice Services Division, shall provide staff for the Committee.

5. **Report:** A report shall be provided to the juvenile court directors, the Committee on Juvenile Courts, and the Administrative Director for consideration and action.
