Limited Jurisdiction Courts Narrative Summary

The revenue data provided here are for the Limited Jurisdiction Courts of Arizona. The figures were compiled from quarterly revenue surveys submitted to the Supreme Court during fiscal year 2014. Major revenue categories shown represent monies collected from four sources:

FINES, SANCTIONS, FORFEITURES: Revenue from monetary penalties assessed in criminal, traffic, and juvenile matters, and bond monies that were forfeited;

SURCHARGES: Revenue from monetary assessments authorized by statute above and beyond criminal and traffic penalties and certain civil and other fees;

FEES: Revenue from collectible fees for services of the court and chargeable aspects of case processing;

OTHER REVENUE: Revenue from sources not otherwise specified.

Total revenue collected by Limited Jurisdiction Courts decreased from \$293,163,260 in FY 2013 to \$288,567,491 in FY 2014, a decrease of 1.6%. Justice Court revenue decreased from \$109,637,623 last year to \$106,431,280 in FY 2014, down 2.9%. Municipal Court revenue went from \$183,525,637 in FY 2013 to \$182,136,211 in FY 2014, a decrease of 0.8%.

The fines category is the largest at \$117,903,492, accounting for 40.9% of the total limited jurisdiction court revenue. Most of these fines (\$79,186,621 or 67.2%) were assessed in Municipal Courts. Surcharges accounted for 27.5% of the total limited jurisdiction court revenue with of \$79,417,859 collected during FY 2014. Combined fine and surcharge revenue decreased 2.3% from \$201,961,976 in FY 2013 to \$197,321,351 in FY 2014. An additional \$91,188,021 was collected during FY 2014 for court fees, fee revenue accounts for 31.6% of the total limited jurisdiction court revenue. The majority of fee revenue is collected by the municipal courts (\$51,125,213 or 64.4%).

Maricopa and Pima County Justice Courts comprise 55.4% of all Justice Court revenue. Municipal Courts from these two counties constitute 84.6% of all Municipal Court revenue. The two largest Municipal Courts--Phoenix and Tucson--not only account for 38.1% of all Municipal Court revenue, but 24.0% of the revenue from all Arizona Limited Jurisdiction Courts. In all, Maricopa and Pima County Limited Jurisdiction Courts collect 73.8% of all Justice and Municipal Court revenue.

The Annual Trust Money Collection Summaries show that the Limited Jurisdiction Courts processed \$27,996,115 in "pass-through" trust monies during FY 2014, most of which were for bail bonds.

Some of the FY 2013 figures may not correspond to figures published in last year's Data Report due to corrected information received subsequent to publication of the Report. Revenue reports received from courts are checked for mathematical accuracy, but are not audited by the Supreme Court.
