


## SUPERIOR COURT Narrative Summary

**The Superior Court is the state’s general jurisdiction trial court. Arizona’s Superior Court has 15 branches, one for each county in the state. Superior Court has jurisdiction over all cases except small claims, petty offenses and violations of city ordinance/codes. The Superior Court also acts as an appellate court for justice and municipal courts.**

Total filings (including transfers in) increased 0.6% from 200,038 in FY 2013 to 201,299 this fiscal year. Superior Court’s largest category, civil filings, experienced a decrease of 5.6%, from 62,770 in FY 2013 to 59,271 in FY 2014. Within the civil category, contract and unclassified cases saw the largest filing decreases while the tort-motor vehicle category saw the largest increase. Criminal filings, the second largest category, increased by 7.7%, from 48,654 in FY 2013 to 52,402 in FY 2014. Domestic relations filings also increased, up 3.0% from FY 2013 to FY 2014. Within the juvenile category, both adoption and dependency filings increased by 11.0% and 8.5%, respectively. During the same period, juvenile delinquency filings decreased by 10.1%. The two remaining major categories, Probate and Mental Health, both had decreased filings of 1.0% and 2.8%, respectively.




Total dispositions (including transfers) decreased from 204,438 in FY 2013 to 199,631 in FY 2014, a decrease of 2.4%. Criminal, domestic relations and mental health terminations increased while civil, probate and juvenile terminations decreased. The total pending

caseload increased 1.3% from 204,784 at the end of FY 2013 to 207,424 at the end of FY 2014.

Superior Court held 5,640 trials during FY 2014, an increase of 17.1% from FY 2013. Domestic relations trials account for 68.7% of the total trials, these trials increased by 18.3% from FY 2013 to FY 2014. Criminal trials also increased, up 15.3% during the same period. Total jury trials held increased by 13.7% from 1,274 in FY 2013 to 1,448 in FY 2014, these account for 25.7% of the total trials held in Superior Court.

Petitions for orders of protection rose 3.0% from FY 2013 to FY 2014 while injunctions against harassment decreased by 5.0% during the same period. Superior Court held an additional 4,398 protective order review hearings during FY 2014 for both orders of protection and injunctions against harassment. An additional 715 emergency orders of protection were also issued.



Data for all counties except Maricopa and Pima were estimated for FY 2014 due to the transition from the AZTEC case management system to the new case management system called AJACS (Arizona Judicial Automated Case System).






# SUPERIOR COURT CRIMINAL CASE ACTIVITY, FY 2010 - 2014 CASES FILED AND DISPOSED


# SUPERIOR COURT CIVIL CASE ACTIVITY, FY 2010 - 2014 CASES FILED AND DISPOSED




