Limited Jurisdiction Courts Narrative Summary

The revenue data provided here are for the Limited Jurisdiction Courts of Arizona. The figures were compiled from monthly revenue surveys submitted to the Supreme Court during fiscal year 2017. Major revenue categories shown represent monies collected from four sources:

- **FINES, SANCTIONS, FORFEITURES:** Revenue from monetary penalties assessed in criminal, traffic, and juvenile matters, and bond monies that were forfeited;
- **SURCHARGES:** Revenue from monetary assessments authorized by statute above and beyond criminal and traffic penalties and certain civil and other fees;
- **FEES:** Revenue from collectible fees for services of the court and chargeable aspects of case processing; and,
- **OTHER REVENUE:** Revenue from sources not otherwise specified.

Revenue collected from Limited Jurisdiction courts decreased from \$270,280,008 in FY 2016 to \$251,765,038 in FY 2017, a decrease of 6.9%. Justice Court revenue increased 2.1%, from \$103,499,015 in FY 2016 to \$105,675,113 in FY 2017. During the same period, Municipal Court revenue decreased 12.4% from \$166,780,993 to \$146,089,924.

The fines category is the largest with \$98,446,701 collected during FY 2017, accounting for 39.1% of the total limited jurisdiction court revenue. Most of these fines (\$61,797,981 or 62.8%) were assessed in Municipal Courts. Surcharges accounted for 25.7% of the total limited jurisdiction court revenue with \$64,789,160 collected during FY 2017. Combined fine and surcharge revenue decreased 7.9% from \$177,165,186 in FY 2016 to \$163,235,861 in FY 2017. An additional \$88,457,526 was collected during FY 2017 for revenue originating from court fees. The majority of fee revenue is collected by the municipal courts (\$45,282,293 or 51.2%).

Maricopa and Pima County Justice Courts comprise 56.4% of all justice court revenue. Municipal courts from these two counties constitute 82.5% of all municipal court revenue. The two largest municipal courts--Phoenix and Tucson--not only account for 28.8% of all municipal court revenue, but 16.7% of the revenue from all Arizona limited jurisdiction courts.

The Annual Trust Money Collection Summaries show that the limited jurisdiction courts processed \$37,135,139 in "pass-through" trust monies during FY 2017, most of which were for bail bonds.

Some of the FY 2016 figures may not correspond to figures published in last year's Data Report due to corrected information received subsequent to publication of the Report. Revenue reports received from courts are checked for mathematical accuracy, but are not audited by the Supreme Court.
