


## How to View Court Case Documents in AZTurboCourt for Maricopa County

There are three ways to access court case documents in AZTurboCourt for Maricopa County filings

### *Access using 'Recent e-filings' to view documents within Formset*

1. Log in AZTurboCourt and select 'Recent e-filings' under the User Menu.



2. Enter the formset or case number in the search box. Entering either will produce a message at the top of the screen that includes a hyperlink to the Formset and the case number




