

How to View Court Case Documents in AZTurboCourt

Appellate Courts

Notes: ***File Stamps and Endorsement Pages***

For the Appellate Courts (Arizona Supreme Court and Court of Appeals Division One) documents submitted and accepted through TurboCourt are not file stamped. Instead, a separate endorsement page is generated. Documents generated by the Court of Appeals (Orders, Notices, etc.) will include a file stamp.


Accessing Documents

The View Court Case Documents tab displays a list of all documents filed into the court for that case. An important note for appellate courts is that the View Court Case Documents tab only displays documents submitted into the court noted in the formset.

For example, documents filed into the Court of Appeals case are accessible through the View Court Case Documents tab from a formset successfully filed into the Court of Appeals. When the case moves to the Arizona Supreme Court, the documents filed into the Court of Appeals will not appear in the View Court Case Documents tab for a formset filed into the Arizona Supreme Court until after the case initiating document is successfully filed. In this interim period, access to documents filed into the Court of Appeals, remain available through the View Court Case Documents tab from a formset successfully filed into the Court of Appeals.

Retrieving Endorsement Pages

1. Log in to AZTurboCourt and select 'Recent e-filings' under the User Menu.



2. Enter the formset or case number in the search box


