ORDER

An initial review of the complaint filed in this matter reveals that the issues raised are either legal or appellate in nature and do not involve allegations of ethical misconduct.

The complainant alleges that a lower court did not send his evidence and photographs, which he feels proved his case, to the appeals court for review. However, the case files show that all documents and exhibits that were properly admitted into the lower court case were transmitted to the appeals court.

It is clear on the face of the complaint that the complainant is seeking to overturn the judges' rulings. Because the commission is not an appellate court and cannot change a judge's decisions, the complaint is dismissed pursuant to Rule 16(a).

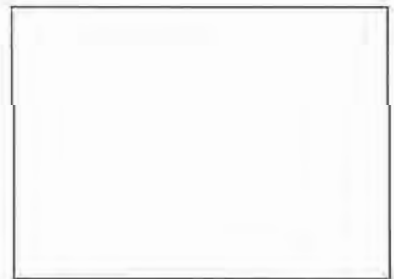
