A review of the complaint filed in this matter reveals that the issues raised are solely legal or appellate in nature and do not involve ethical misconduct.

The commission is not an appellate court and cannot change a judge's decisions. The complaint is dismissed pursuant to Rule 16(a).

My attorney then told me that she would in fact re-enter
the case. On Wednesday, the [] I went to meet my attorney
~~for~~ pretrial preparation at which time she told me that
she will not represent me. I desperately tried to find
representation at that time for my trial on [] No one I
spoke with - was able to take my case under such short notice.
I ~~then~~ pleaded ^{with} a lot of tears and requested Judge
[] to continue trial. Three times - I tried in her
Courtroom, and I also tried by filing an emergency
continuance based on no representation on the []
all attempts were denied! Judge [] also stated (Frustrated)
to me in the courtroom as I went, ~~that~~ []
you have 5 minutes to pull yourself together, because
we will proceed with trial today."
The petitioner, on the other hand, was able to file
multiple continuances in this trial previously, which
were granted, compared to my one request - in my time
of desperate need - which was denied. ~~I was~~
I was a victim of domestic violence, as well as my

then [redacted] son. The harassment from the other party still continues, as I fear I will lose my job because of it. My [redacted] daughter is in the middle, and I believe that Judge [redacted] ruling is completely prejudiced due to the other party [redacted] being disabled. He was not disabled at the time he beat me, and was mean to my son. I encourage and even ask for whom ever reads this to obtain the ~~monitor~~ transcripts from trial on [redacted] (1:30)

As you should read the prejudice involved in the judge's words and actions/rulings. [redacted] has one count of assault on his record which Judge [redacted] seems to ignore. This has been a nightmare beyond nightmares and I thought that the justice system would intervene and stop this every day harassment that I endure. I would like my daughter to know her father but on a limited basis due to his history of Domestic violence, anger issues. I most importantly would like to continue with my life as a small family with my children + without these issues of Domestic violence. Judge [redacted] [redacted] will not hear me or my pleadings in this matter. Please, whomever reads this, please help me resolve this.
