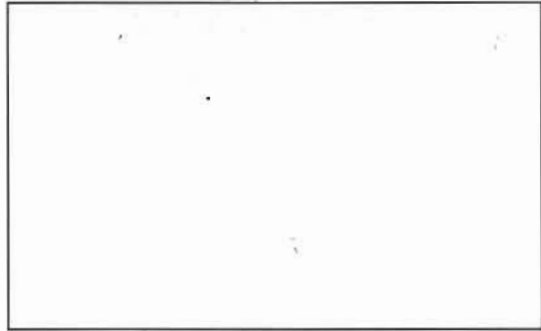

Dear Madam or Sir,

I would like to file a complaint against Judge in relation to the matter, Case No. filed by I approached of the Law Firm to represent me and he suggested that he would draw up a response to the motion and I would file it with the court since there was not a lot of time to review the complaint. I had submitted the matter to my attorney who was handling my divorce from my former spouse who had tried numerous times to murder me, and he only delayed the process more by failing to return the documents to me or notify me that he would not be able to represent me in Arizona. All of this debt was a result of fraud, the court's inaction, and I was a victim of medical malpractice, attempted murder, assault, and a host of other concerns. I had wanted to represent me and I filed the court papers in as he had suggested. Following that I received additional papers from the Court and sent them to and asked to retain him. Neither he nor the court responded to me until I would find that the judge would rule on the matter anyway without me being present or consulted, and he awarded a financial settlement to He has essentially paid those people who have tried to murder me, defraud me of my money, and they have all profited from these criminal acts against me. This is much the same as the ruling by Judge in my divorce matter where he awarded nearly to my former spouse for her attempts to kill me. This was done
