[redacted] informed me in the past that I would need to be assigned a Federal Attorney in order to prosecute these Judges. If that is the case you had better assign me one. Because I deserve and intend to seek damages for these Judges, what I view as both illegal and unethical behavior.

Judge [redacted] for what he did in [redacted] violation of Code #3. [redacted] was 16, CAC for children 15 yrs or younger, Miscarriage of Justice against me.

Judge [redacted] for what he neglecting to following through with his own court orders as of [redacted] of sealing the website. Neglecting to inform me that just because the website was sealed that everything still appeared on the Justice Court's Clerks' Office data base and would therefore still be picked up when background checks were done. The Judge neglected to tell me that when the year was up the only real way I could clear my name was if my attorney and I appealed to Superior Court to have the 2 DVs & CACs and 3 HAs Expunged from my record. However, neither the Judge nor my Attorney ever made any mention of this to me. I learned all of this information from calls through out the years and learning to ask the right questions from the Justice Court's Clerk's Office. And for Judge [redacted] to have the nerve to raise a stink when I contacted him directly when I learned that he had never sealed the website in [redacted] and went complain to my attorney well I think this makes him an unaccountable total ass. And then after getting a totally malicious and contrived Harassment Order from [redacted] that says "she has approached children and has been accused of being a child molester years ago as it states in her folder from her [redacted] petitions for crimes against children and domestic violence". I knew immediately to go to the website and I was correct, [redacted] DVCAC was back on the website [redacted] and I do not know how long it had been back up their. I contacted Judge [redacted] directly and [redacted] who had fired me because she did a bad job. Again not one word of accountability, regret, apology nothing from the Judge. [] both knew I took my [] to court in [] and got the DVsCACs sealed and revoked and what [] mentions about me coming over and cussing at her children [] is when she invited me in and I told her about the Judge forget to seal the website and I did not know her son was in the other room and I apologized and they both said "don't worry about he/I hear worse in high school" and then it appears totally out of context on her harassment order. The gift returning thing did not even happen to [] I asked for some really nice Turquoise slab earrings back that I had giving to [] next door neighbor [] for no reason at all, I'd cut my hair short, I wasn't friends with her or [] any more because they thought they had the right to tell who ever they wanted that I was mentally ill and I told them I would like them to stop that it was my business to tell who I wanted they disagreed disrespected my wishes and that was the end of our friendship.)

Judge [] for what she did in [] and took no accountability for violations of Code #1 and #3.

Obviously Judge [] asked for no evidence of any of these complaints because there are none. The day I filled out my paper work for the hearing I confronted Judge [] for her allowing them to write perjury and slander down on the court documents. Her response "they take an oath to tell the truth it is up to them."

Judge [] took absolutely no accountability at all.

What if I had been a child molester? She was not responsible to see if I were registered. To find out if I were indeed approaching children? What my record was? I find that remarkable.

Judge [] for what he did in [] violation of Codes #1 and #3. Allowed CAC for [] when "children" were ages 18 and 16 and the law in for children 15 years and younger, a true Miscarriage of Justice against me.
