Judge [] also continued this retaliation I was charged with possession after I was followed across town for minor traffic violation. Officer [] waited outside home over 1 hr in violation of reasonable diligent standard of the 9th circuit. [] then perjured in court denied that he waited for me. This was in fact a S.B.A illegal tactic in retaliation for me asserting my rights in collusion with Judge [] Officer [] also perjured by denying he was familiar with household. I believe he was landlord and neighbor. They had their own retaliation given marijuana by residents which I would explain if you investigate. My passenger was I attempted to subpoena [] canine officer but was told by city prosecutor it was unnecessary because he would subpoena him. He did not and when I politely attempted to question these indiscrepancies I was shouted down by the judge. When I appealed as a indigent I was told I would be charged Bail fee and fine in contradiction of State law. Judge [] fee. I had to show a lawyer [] in violation of law, was sent going to jail. Judge [] then appointed who immediately dismissed my claim without consulting me in violation of American and Az A.B.A code of ethics. Judge [] commented that everyone in [] knew I traffic in drugs. This is a ridiculous accusation and was true of the local law enforcement. A paper was just published and exposed this. Judge [] then promised I would go down. This was because I alerted them to [] and county situation. I was harassed by court insisting I didn't pay fine constantly which I always did and my mother would be required to take receipt I was afraid to be arrested. This treatment cause me mental distress and my civil rights complaints were lost because of it. Judge [] behavior amounts to retaliation and moral turpitude and all his work should be scrutinized, especially charging indigents to appeal. I am also aware he is on []
