THIS IS AN OVERVIEW OF WHAT TOOK PLACE.

JUDGE [REDACTED] ACCEPTED MY PLEA AGREEMENT IN [REDACTED] MY PUBLIC DEFENDER MADE STATEMENTS SHE COULD NOT BACK UP. I WENT BEFORE JUDGE [REDACTED] FOR SENTENCING. HE SEEMED VERY DISORIENTED AND ABSOLUTELY UNFAMILIAR WITH MY CASE. HE THOUGHT IT WAS A CLASS 2 FELONY WHEN IT IS A CLASS 6 OPEN UNDESIGNATED FELONY. WHEN I WENT BEFORE HIM HE REJECTED MY PLEA AGREEMENT WHICH I WAS FINE WITH BECAUSE I WANTED OUT OF IT. THAT WAS AROUND [REDACTED] ACCORDING TO #8 OF THE PLEA AGREEMENT I SHOULD HAVE BEEN GIVEN MY OPPORTUNITY TO WITHDRAW FROM THE AGREEMENT. I WAS DENIED THAT RIGHT. I ALSO INFORMED HIM I WAS LOST IN THE PROCEEDINGS. I ADVISED HIM OF THE STATEMENTS MY LAWYER MADE THAT WERE NOT TRUE. I FILED ON HER WITH THE BAR ASSOC. I TOLD HIM I WAS TOLD BY MY LAWYER I COULD WITHDRAW FROM THE PLEA AT ANY TIME. AMONG OTHER THINGS. MY NEXT HEARING HE REACCEPTS THE PLEA GIVES ME 8 MO JAIL 5 YEARS PROBATION. ~~2 YEARS~~ WHICH IS EXCESSIVE ON A CLASS 6 OPEN. I HAVE NO PREVIOUS CRIMINAL HISTORY. NOT AS MUCH AS A TICKET. HE WOULD NOT LET ME OUT EVEN THOUGH HE REJECTED THE PLEA. HE SAID ITS NOT IN THE INTEREST OF JUSTICE. HE THREATENS ME THAT HE CAN GIVE ME 2 YEARS PRISON.
