I would like to file Complaint

allegation that was put in the order.  
I proved in court that he lied and  
presented proof that he had lied. [redacted]  
[redacted] stated that he had obtain several  
orders against me before and that I  
had attacked him at work. This state-  
ment was untrue. [redacted] obtain a  
false order in [redacted] and used  
it against me in [redacted] to  
get his child support relieved and then  
dismissed the order. he also stated  
that I came to his house on [redacted]  
screaming that I was going to kill  
his girlfriend and broke into his girl-  
friends car this never happened no  
was there any police report to support

this allegation because I tried to obtain one. Then he stated that called him several times at 10'clock in the morning but submitted no proof of this. [redacted] stated that I left several threatening messages on his cell phones. He presented no proof of this in court. He stated that I got information from my Job about him and his girlfriend and I was going to attack them both. first of all I was married to [redacted] for almost 6 years and with him for 9 years I know everything there is to know about him. Concerning his girlfriend I had never met her or talked to her in which she also stated in court. [redacted] has made several allegations and has submitted no proof to the Courts that I have committed any crimes against him or any one he knows [redacted] also made allegations about me hanging up flyers at different locations which is not true and he submitted no proof of this. He came into court with some-

type of flyer that I believed, he typed up before the hearing stating that he was a child molestor. Judge [redacted] let this order stand with no proof of any of [redacted] allegation. [redacted] would not let me present my two witnesses to the court and refused to hear their testimony. [redacted] was allowed witness, his father who I have not seen in almost two years who could not have any barine on the allegations at hand because he does not even live in [redacted] and has no clue what had been going on between me and his son. He got on the stand and talked about things that happened several years ago and made a lot of untrue statements. Then his girlfriend testified I didn't even know this person or have ever met her, she told several lies with no proof. I have had my rights to bear arms taken away from me for no reason at all, I have never committed any crimes against the State of Arizona except being guilty

for being a [redacted] female and for not having a [redacted] as my uncle in which [redacted] brought up in court to prejudice the Judge he brings his uncle up in every court case we have to go to court on to win and prejudice the courts. I am a college educated woman who works full time to take care of [redacted] three children without basically any help from him and this is the thanks I get from him trying to make the courts think that I am mentally unstable I resent this statement on this order of protection and would like this order dismissed or retried by another Judge [redacted] has been in trouble with the law all of his life and has constantly lied to get out of trouble. I can not believe that a Judge in Superior Court would keep this type of order in effect with no proof at all, just because I am [redacted] and he is racist. I would like him looked into because of this order of protection and the order

that I was ~~given~~ granted by him on [redacted] due to his harassment and I was granted another order of protection against [redacted] on [redacted]. [redacted] requested a hearing which I was fine with because I had several pieces of evidence in court which stated that [redacted] had been harassing me and threaten me about relieving his child support so he won't go to jail. Judge [redacted] refused to accept any of my evidence and called it uncreditible. I had to file a police report [redacted] with [redacted] PD at my job on [redacted] due to my co-workers hearing him threatening on speaker phone. [redacted] and assaulted me and been charged with it, he has molested his step-daughter and got away with it. He has abuse myself and my children for several years and his uncle [redacted] makes a phone and he turns the whole situation around on me because I am [redacted]. I am starting not to believe in the

Court system in Arizona because I have seen first hand that it does not work for the people who go by the laws of this state. It has more to do with the color of your skin. I am ashamed to say that I am a part of this law enforcement community because of Arizona letting people like Judge [redacted] set on the bench and dictate the laws of this state unfairly. This Judge is racist and he did not stick to the facts of either case. I am asking for a new hearing to be conducted by a fair Judge and not one who is racist. I am sending you documentation and recording of this first hearing and would like for you to listen to it.
