COMPLAINT AGAINST A JUDGE

On the [redacted] Judge [redacted] issued an order of protection against me. This order of protection essentially nullifies the Parenting Plan that is part of the divorce decree [redacted] County, AZ. If the judge is allowed to issue such orders in violation of divorce decrees this should be changed by the legislature or judicial procedure, [redacted] of the [redacted] Justice Court recused himself possibly because he was an actual witness of [redacted] complaint and close association with both of us. Judge [redacted] should have recused himself also because of his close association with [redacted] He personally helped her move from storage in [redacted] to storage in [redacted] AZ, and also helped her locate in [redacted] AZ. [redacted] likes to impress men ~~etc~~ to show her appreciation with her front side. I'm sure she impressed [redacted] and I don't think they were always of "same level". I heard rumor that I believe investigation will bear out that there is a conspiracy between [redacted] and [redacted] to get me thrown in jail, ran out of the area, and to increase my child support payments through this order of protection. My children are also suffering because of this order of protection that keeps their father from seeing them and knowing of their whereabouts all the time.

I realize that this matter concerning my children will need to be settled in Superior Court. I thought that the "Order of Protection" was a "cheap shot" at harassing me and satisfying [redacted] "Anxiety Disorder".

Her anxiety stems from her non-compliance to the "Parenting Plan" and her irresponsibility concerning herself and the children.

The "Order of Protection" was sought after and received to prevent me from sitting next to my children in Church and also that [redacted] might further alienate me from my children by introducing other "daddies" in their lives and increasing the potential for molestation of my children.

There has actually been ~~an~~ incident of molestation since the issuing of this "Order" because of the irresponsible actions of [redacted] and the other Adults involved.

[redacted] can verify this incident.

The "Order of Protection" is frivolous and Judge [redacted] should be disciplined for his actions and involvement.

Enclosed also is a copy of [redacted] complaint ^{also} and the "Parenting Plan".

Judge [] refused to look at or receive a copy of the "Parenting Plan" at the hearing on the [] in [] AZ.

He also said I was being "too protective" of my children.

I told Judge [] that I wanted to appeal his decision. He said he could not find the forms to do so but he would mail them to me.

Knowing that there was probably a time limit to file the appeal, I called the court several times to see why I had not received a copy of the forms. I received several excuses from "the judge is not in" or "he is taking care of personal matters."

I finally received a copy of the appeal form post marked [] which I not able to pick-up from the Post Office until the []

We do not need this type of corruption in these rural areas and Judge [] should be removed from office

[] has "full" physical custody with reasonable visitation rights by me.

We both have "joint" legal custody. The "Order of Protection" interferes with the legal custody
