I [redacted] was informed by my  
Attorney [redacted] a few days ago that  
when [redacted] arrived in [redacted] AZ for my Jury  
trial on [redacted] that my case was already  
done and he did not get a chance to read  
my letter to the judge, due to the fact I have  
had to come back to [redacted] to care for  
my 80 year old mother. I feel that this case should  
be considered as a mistrial due to the fact  
my lawyer was not there to defend me + did  
not get a chance to speak. I have been informed  
that Judge [redacted] is a temporary fill in for  
the [redacted] Justice Court and did rely on private  
Attorney [redacted] for information. This case  
is 2 1/2 yrs old and has caused me extreme  
financial hardship due to FAA will not let  
me back into the Airlines with a pending case.  
Back in [redacted] I already did a few days  
in jail + gave up my lic and followed my  
attorney instructions. Since that point and  
time, 2 1/2 yrs ago I have not been in further  
trouble and do not feel I should have to do  
anymore jail time for the 2 1/2 yrs of financial  
hardship. I have lost over 25 grand a year  
due to the delay of this case and feel I have suffered  
long enough. I do not expect to return to Arizona.

I feel that my jury trial on [redacted] should be treated as a Mis-Trial due to Judge [redacted] lack of experience judgement and private atty [redacted] being allowed to give advice at the trial. As you can see my Sentencing is Sked for [redacted] I am currently working a Minn Wage job through the temp Agencies at this point and time. I must get my Airline job back in which I had trained for at the Airline Academy [redacted] in order to be able to help support myself and my Mother [redacted] whom is 80 yrs old and needs my assistance daily. I feel I have more than paid and suffered for this case. If they still seek more jail time, I will lose my job and my home. As you can see I have lived 2 1/2 yrs under the Courts thumb for a 1st time case. I wrote a letter for the judge on my behalf that he did not even bother to listen to the defense attorney [redacted] [redacted] I have also sent a letter to the Supreme Court on this issue. I feel I was totally discriminated by the [redacted] Arizona Justice Court and the General public has every right to know about it. Please help. I was already out of my car when officer told me to get back in car.
