My ex husband, [redacted] filed for divorce in [redacted] At the time, I was not employed and he was making over [redacted] He retained (2) prominent attorneys, [redacted] while I used my fathers credit card to retain [redacted] she dropped me for lack of paying and [redacted] has been kind enough to pick me up. Judge [redacted] allowed my ex husband to take out [redacted] of equity in his home in [redacted] right in the middle of the divorce. My ex husband also claimed my wedding ring went "missing". I know he has that ring and in order to avoid insurance fraud, I would not take a dime of the insurance money he collected of [redacted] (I can provide you with [redacted] number of [redacted] for [redacted] who is also Former [redacted] and flagged this claim as Fraud.)
