Dear Sirs,

I am writing in regards to my complaint against Hon. Judge [redacted] and my Family Court matter that he oversaw in [redacted]. It is the hopes of all of us that you read this and listen to the audio and call the people I have listed. We emlore upon you, that you make a change so as no other family has to go through what we have,

My first concern in regards to Judge [redacted] was a emergency telephonic confrence that I apperard for without counsel (we did not have the funds yet to aquire one). I called the court house from my chaperl in [redacted] with my Chaplin present. It became quite clear at that point that Judge [redacted] was biased agaienst, not only the Armed services ( aserious violation on your Canon, nut also was not upholding the integrity of his court. He would not let my Chaplin [redacted] of the [redacted] listen in on conversation as my spertiual counsel, but also blantently dismissed no desired to be informed about the workings of the [redacted]

I am more than sure is you would take the time to listen to the actuall tape you will also hear it. Point in fact, I was so amazed by his verbage WE were all speechless. This is a conduct he would continue with throughout the entire ordeal.

After some time my husband and I were able to retain an attorney [redacted]. The opposing counsel continued to serve me motions and would prevale, even though the Judge knew that, due to his ruling prior the childern and I were living from [redacted] to another and my husband was sent to his forward deployed unit in [redacted]

We eventually went to court. [redacted] My mother, an [redacted] my best friend, [redacted] in the [redacted] and my step mother, [redacted] When you call any of the above, they will tell you we were not even sure he was awake, and it was right befour [redacted] it was visually obvious that, not only was he half asleep, but he would look around, at the ceiling, the floor etc.

We all feel Judge [redacted] both verbally and non verbally through his actions and words, could have been asleep and allready in his mand made a decission.

His misconduct continued when he allowed. Tape recording and phone messages from services member and dependants. Harressment by the [redacted] over the entire course of this mockery. I am pritty certian it is either against [redacted] laws to do that. Also he omitted "evidence" that was unfounded.

It took Judge [redacted] close to 3 weeks to make a "decision". Next violation. Considering that it was a "family" court. Considering he was well aware of the situation he had placed myself and CHILDREN in I feel that the timley manner was abused. We feel he is boderline if not guilty of child abuse.
