RE what has shredded my wealth + maligned my life since 1993

Sire: first, a note on the [redacted] Police Force...with no assistance from [redacted] Judiciary....

Just before retirement, Police Chief [redacted] furloughed [redacted] cope: [redacted] the area of the homeless one man for not reporting it: [redacted] the homeless-- reported in the [redacted]

Then again, [redacted] bond for 'trespass' by winning [redacted] in [redacted] Casino, on [redacted] Judge jumped in a month later with [redacted] fine + [redacted] fine for winning in the [redacted] Cas. to be able to go to his father's funeral in [redacted] 2 yrs earlier. When Judge [redacted] had taken those sums out, I got the refund!

All this no doubt to put me out of my home so [redacted] and his [redacted] wife could have the property which I had bought, cash!

By reporting this affair to the [redacted] Bank, <sup>President</sup> causing the removal of the Bank Manager, ~~financial~~ financial advisor for lawmen+removal of Sheriff [redacted] from the ballot, I became enemy of the law. (Later removing the 'telling' teller of a branch of [redacted] when I got a bill from [redacted] hospital for unitemized bill of [redacted] when I had just [redacted] in the bank!)
