I HAVE DONE MY PART, I HAVE WRITTEN LETTERS AND FILED MOTIONS. NOT BEING AN ATTORNEY, I WROTE TO MY COURT APPOINTED COUNSEL FOR HELP, SHE ([REDACTED]) BLASTED ME WITH A LETTER (SEE ATTORNEY LETTER)

THE PROBLEM IS WITH [REDACTED] HE IS PREVENTING ANY RELEASE OF THESE RECORDS

ALL I AM ASKING FOR IS RELEASE OF PUBLIC RECORDS SO I CAN COMPLETE MY PCR PROCEEDINGS
