We had a case come to [ ] Justice Court, landlord Tenant case, It would not have gone that far except JP [ ] gave legal advice and even looked up & copied for other party, also explained to a novice deputy [ ] how to handle serving a forcible detainer, not telling us or deputy the truth, He told deputy that it meant he could make us abandon our mobile home and not return with threat of arrest, It was also served the day after we were served a 5 day notice to pay or quit, we were moving when the police came and said we had to leave the property, we tried to object, the deputy said that is how he was told to interpret the forcible detainer word for word from JP [ ] well that is when the world changed for me & my family, we were put out of our mobile home by force, we couldn't get our pets or my medications we begged for 4 days that I had to have my meds, I have to take 12 different ones morning & night, I'm a service connected disabled veteran, the VA writes them all, it's life threatening, not to have them, at least 6 people went to the judge & sheriff's office to help me obtain my meds, they didn't care, tough luck it was 120 degrees with no water, no elec, the result was I had a stroke & flashbacks from my PTSD in the military, I spent 9 days in VA 3 in ICU, they said 15 min more and I would have died, I am now crippled on my left side, for how long who knows, we asked to change judge because of prejudice when it was scheduled for court, also a delay because I was still in VA Hosp,

We were granted a New Judge [redacted]  
From [redacted] we were Elated until we Found out  
JP [redacted] got her to come to [redacted]  
and use his court, we knew we were Doomed. He controls  
[redacted] AZ, we appeared for court, we had asked for him  
to be NO Part of our hearing, NO SUCH luck. He SAT behind  
Wall, Just off to the Side of bench, he Instructed & commented  
Thru the Whole Process, JP [redacted] SAID she was going to  
Dismiss on ground of not Proper Procedure on 5 DAY Notice/  
Forcible Detainer, Just before she was Done, he Appeared From hiding  
Spot, In front of Entire Court and ASKED JP [redacted] to step  
in his office, she said she'd be Right BACK with decision?  
they Conferred in Private, During court, she Finally Came back  
and SAID we would Continue with TRIAL, we were Dumfounded,  
we objected and ALSO TRYED to Submit AFFADAVITS and were told  
to only talk when she ASKED US TOO, we Did not get a Fair, Impartial,  
Verdict or Treatment FROM them, he told her what to do.  
She told us we should have known that a Forcible Detainer  
didn't mean we had to leave our house, we Showed PROOF that  
The JP [redacted] had advised the Plaintiff and made a copy for him  
on how to lie to us & Deputy, ONCE we were Forced out of our mobile  
home, they won't let us get our STUFF, we have Appealed wrongful  
-Judgement and are waiting, homeless now, while the Cops  
keep us out and let the Thieves TAKE our possessions, JP [redacted]  
has CALLED us Queens in open court, shown visible Prejudice  
toward us, and ALSO has Used his Power to keep us out of  
our local Church, he is on BOARD, also we have been blocked from  
getting a copy of our TRIAL Record for Appeal, it has to be Filed  
Tomorrow, he SAID he would TRY to Find it, we Paid for a copy.  
Justice Denied again at his hand  
why did we fight for our Freedom and get NO Justice [redacted]

We have went to [ ] Justice Court Again, to Receive a Copy of OUR COURT CASE, at least 6 Times now at 80 miles EA, we Paid to get it the DAY of Court, NOW JP [ ] is at it again, he SAID he was going to Copy us one, we waited For 2 hrs, NO COPY, he had every excuse under the Sun, We believe now that he has Conspired with the Plaintiff to derail OUR CASE and has Changed or Deleted the Record, We had him Removed From our CASE so he Couldn't Affect its Outcome, he has been Involved the Whole Way, NOW our Property is Being Stolen/TAKEN under his Direction Including Weapons, he has even convinced the Sheriff's Deputy's not to take a report, and Not Allowing US our Property, they Insist its a civil matter 'Weapons Stolen' is not Civil, and it is Frxin to Escalate into to a out of Control ISSUE that won't be Civil, we have asked For help to Stop this Madness, County Atty, Atty Gen AZ, FBI, ATF, Sheriff's Dept, they Dont CARE, when A JP In open Court CALL you Queers and get away with it, we no longer have Justice, our Freedoms ARE gone, and stripped of Rights that I Fought For, Im a disabled Vet and even that Doesn't count FOR anything, Im about to give up & throw in the towel.
