I know [redacted] personally and I have seen corrupted officials before but this man takes the prize. I am also close friend with a clerk in his office and that clerk has told me about all types of illegal and immoral actives of that Judge [redacted]. I have case numbers and situations that should be investigated. Judge [redacted] has given illegal court favors to his friends like [redacted] who I personally knows has several cases with the court [redacted] and many many more. Judge [redacted] has been reported before to his supervisors for unethical behavior with one of his clerks by the name of [redacted] [redacted] who also has lived in [redacted] all of her life and I know. She herself have shared stories of gifts given to her by the judge and I've questioned if these gifts were bought with taxpayer money. My friend in the court told me that judge had recently purchased a expensive designer handbag for [redacted] and did not do the same for his entire office staff. Also his friend [redacted] has had several cases in the court [redacted] [redacted] and the judge allowed for special treatment. This judge has also been brought up on charges in the past relating to his relationship with a young lady that no longer wanted to be with him but he kept harassing. This judge is performing weddings during regular court hours, which I have been told is not allowed. I was also told that judge had a racecar driver [redacted] in his court for a ticket he received and allowed this guy to come into his office to hear his case and showed special treatment for this man. Other people he has treated differently than others is [redacted] [redacted] some of these people I know myself. I was told that the other clerks and the management are afraid to speak out against the judge because of the fear of being fired, those people shouldn't have to work like that and the county should be ashamed for allowing these workers have to suffer in silence while this judge breaks the laws, is corrupt, shows favoritisms not only with people coming into the court, but with court staff. I think its about time for Judge [redacted] to be held accountable for his unethical behavior and I hope that someone with integrity looks into that court and stops this man from being the unethical person that the people elected to office. As a taxpayer I am mad about this judge getting away with stuff so I am sending this letter to everyone that I think can address this judge and do something.
