- ① The Judge has ruled that when children visiting father, they can protect themselves against father's brother who is a level 3 registered sex offender. That father just needed to keep an eye on the children if his brother is around.
 - ② The Judge ruled that I was not authorized to have any participation in the listing of the marital residence because I had previously insisted on disclosing significant mold and remediation that had occurred in the home. The Judge left me in a vulnerable and potentially liable position with regards to a potential claim against me for non-disclosed material information about the home.
It is my belief that my spouse & the realtor have not made full disclosure regarding the home.
 - ③ The judge appointed counsel for 4 minor children a set of triplets 11y old a 16y old. Spouses litig requested a hearing for change of custody and asked for psych eval.

and a 2 hr. hearing. My atty asked for a 3hr hearing. Judge set it for 1 hr. She took some testimony during the hearing and changed custody to father without hearing Childrens Court Appt attorney present w/o hearing what the children wanted. and with' out taking into ac Children's best interest. She made a finding on the record to satisfy statute about best interest requirements.

④ my attorney filed a motion for Reconsid judge denied & stated that it was only a temporary order and she didn't need to make a record regarding the children's best interest.

⑤ I am a stay at home mom without previous employment. judge would not award spousal support at the beginning of case because the home builder was paying for rent. when that stopped I was left without support other than child support. I was left with no home, no financial support and then no children and ~~no~~ no recourse.

⑥ I was ~~sup~~ suffering from a debilitating undiagnosed illness, during this time I believe that the judge made a decision with out full understanding of my problems, and she always favored my spouses position.

I went to stay with family after the children were taken away from me and have been diagnosed and treated for advanced kidney disease.

⑦ At a subsequent request for the children to travel to Missouri to visit me, the judge denied the expeditied request because she was on the bench from 8-5 (I have inclosed her case for that day.)

I returned to [] for a hearing on [] the judge ruled that I could not have unsupervised visits because that was what she intended in the [] hearing.

There has been no valid foundation for any of ~~the~~ her rulings and has disregarded the law and my rights as a parent.
