JUDGES TO THE BEST OF KNOWLEDGE HAS STEPPED DOWN ON  
THIS CASE OR CAUSE. WHY? I HAVE ASKED FOR TRIAL ON  
ALL ISSUES HAVE BEEN DENIED EACH TIME. NOW I  
MUST APPEAL THIS CASE. I AM MY OWN COUNSEL NOW.  
I DON'T CLAIM TO KNOW TOO MUCH ABOUT THE LAW JUST  
A LITTLE I TOLD JUDGE THIS ON THE PHONE THAT THEY  
ALL HAD MERIT <sup>ALLEGATIONS</sup> IT IS VERY HARD TO WIN ON ANY ISSUES  
IF ATTORNEYS TURN IN AFFIDAVITS AND HAVE THEIR  
CLIENTS SIGN AFFIDAVITS AND PERJURY THEMSELVES.  
THIS HAS BEEN DONE TO MY WIFE'S CASE AND MY  
SISTER IN LAW ON ALL ISSUES. JUDGE HAS  
NOW SIGNED A COURT ORDER JUDGMENT CREDITOR  
FOR <sup>TO TAKE</sup>  
MONEY ILLEGAL FROM ON TRUST AND ADDED A THIRD PERSON  
THAT HAS NOTHING TO DO WITH ON TRUST. THIS IS AN INJUSTICE
