 did not witness My Trial, Please ALLOW
 me Some kind of COMPASSION AND Do what
 is Right. I've Suffered Enough AND I
 ASSURE you That Further Action will be
 Taken if Someone Dosent intervene
 immediately. Dismiss This CASE AND
 Let This UnJustice Behavior REST.

 asking for someone to please assist me in this matter. Please
