AFTER I HAD PAID HIM THOUSANDS OF DOLLARS IN ADVANCE
TO TAKE ME TO TRIAL. THIS COMPLAINT IS AGAINST THE
JUDGE IN THIS CASE, JUDGE FOR ACTING UNFAIR
IN THIS COURT PROCEEDING BECAUSE THE JUDGE KNEW AND
HAD FULL KNOWLEDGE THAT MY CONSTITUTIONAL RIGHTS WERE
IN FACT BEING VIOLATED. IN VIOLATION OF 28 USC, 1343(C)
1-4. I'M AWARE THAT THERE IS A LEVEL OF ADVOCACY BETWEEN
THE ATTORNEYS AND THE STATES DEPUTY COUNTY ATTORNEYS,
HOWEVER I WAS OF THE IMPRESSION THAT THE JUDGE WAS
SUPPOSED TO BE FAIR AND IMPARTIAL IN ALL CASES. JUDGE'S
ACTIONS AT THE VERY LEAST GIVE THE IMPRESSION
OF BIAS AND IMPROPRIETY, AND THE WORST WERE AN
INTENTIONAL VIOLATION OF MY RIGHT TO DUE PROCESS AND
A FAIR TRIAL BY AN IMPARTIAL JURY. THEREFORE, I DO
BELIEVE I WAS VICTIM TO A CONSPIRACY BY THE
JUDGE, COUNTY ATTORNEY AND MY COUNSEL OF
RECORD. THANK YOU FOR YOUR
COMMISSION'S ATTENTION IN THIS VERY SERIOUS MATTER.
