The commission reviewed the complaint filed in this matter as well as the recording of the proceeding and found no ethical misconduct on the part of the judge.

A judge has 60 days to make a ruling, and the ruling was ready in less than ten days. In addition, when an appeal is in progress, the underlying payments must be made unless a supersedeas bond in the full amount of the debt is posted with the court. The other issues in the complaint are legal issues, and the commission cannot make legal decisions or change a judge's ruling.

The complaint is dismissed pursuant to Rules 16(a) and 23.
