**ORDER**

The commission reviewed the complaint filed in this matter and found no ethical misconduct on the part of the judges. The issues raised primarily involved the facts in the underlying case, and the appropriate remedy would have been to appeal the judge's decision. A judge is permitted to advise a defendant that if they do not comply with the conditions of release, including court-ordered tests, they may be incarcerated.

The commission is not a court and cannot change a judge's decisions; therefore, the complaint is dismissed pursuant to Rules 16(a) and 23.

This letter and complaint is in regards to the above mentioned Judges, and of the Court. Unfortunately I must tell you my story before any of this makes sense.

we were peacefully at home when my son, who also was at home in the front of our house was approached by a Police Officer named who quickly approached and his friend seeking out a victim for road rage. He was yelling profanity and ordering the two young men to sit on the ground. When my fiancée, and I heard the yelling and cussing we quickly approached the front of the house to see what was going on. Officer had his cite glued to when I walked toward Officer walked to side and kicked him to the ground. Before knew what was going on got his taser gun to shoot while down when the bottom of the gun fell off; he then called for backup when 2 more cops were on back.

There was no probable cause for this to happen. They took to , transported him to county. issued a traffic citation, then it went to a misdemeanor at the Court and mysteriously dismissed. Never knowing how or why it was dismissed Court sent the matter to Court where it was turned into 2 felonies of resisting arrest and disobeying an officer.

We filed claims against Risk Management after the event the "retaliation" started and has not stopped since then.

In addition to that under Case another cop was performing a search for a little girl in an apartment complex where one of friends lived. Again mysteriously enough was charged with possession of marijuana during an illegal search. The cop in that matter did not recognize at all at the hearing and Judge allowed that. The cop at the second hearing obtained a copy of driver's license from MVD for identity.

are the two felony charges wherein is trying to defend himself. He was first physically beat up by cops in and then threatened with his future, his record and his life by Judge who maliciously prosecutes him every time in front of her that he will go to "jail" if he does not abide by urinating for Pretrial Services and being abused further.

After one of hearings because did not make go to jail. tried to detain

our family has been tramatized by the events and threats of these Judges who continuously look at my son as if he has committed a serious crime.

I spend hours upon hours looking for ways to help my son heal from all of this while

he is being viciously prosecuted for no reason and trapped in a relentless court system.

I have been afraid to report these happenings for [redacted] has another review hearing and I'm afraid these Judges will make it worse for him.

I am sending to you the articles out of the newspaper: 2 of the 3 cops have resigned from the police force who attacked [redacted] is the person who transported [redacted] to jail. Imagine your son being beat down before your eyes and then driven to [redacted] jail with a cop who is drunk, on drugs and without a driver's license!!!!!!!!!!!!!!Amazing.

My son is a good person. He is a Mother/Father to his [redacted] daughter, He is with his daughter every day of her life, loves and adores her. [redacted] is very depressed thinking his future could be in jail away from his little girl and looking at 3 felonies that would ruin his life and be on his record forever.

I hope you understand my complaint and cry for help.

I hope you can help retrieve my son from being a "VICTIM" and being maliciously prosecuted for no reason by Judge [redacted] and Judge [redacted]
