He said "I see you and your children" The truth is that he got the credit of being the builder because he is a man. I ask myself did the poor man spend days at the city and looking for material and not eating all day.

Unbelievable that after I work for all this for years going to LA to buy furniture I have I little furniture for 28 years ago and going to swap ,etc to sell to get money to build my house and I mortgage my house a lots of time and a lots of time I paid it and to build those duplexes sometimes while I was talking to the loan officer at the bank over and over phone and in person I was in front of the stove cooking for him and my kids. I do everything for this man and he pays me like that betraying me robbing me abuse me

Unbelievable the extreme of this judges wrong doing the church gave me the mortgage payment for my house, my car is broken, I have no money to feed my kids, I can not pay the utility bills . I driven the " new " car from my daughter which saying I bought for my kids, is a Saturn 1998 and 1996 camaro for my son.

I made a lot of sacrifices which my kids also worked having after school jobs after school camaro was bought for my oldest son for his graduation which they continue to attend college and im very proud of them they are very good kids while my ex-husband buy a new 38K hardly Davison motorcycle, drives a 2006 for F-150, and jaguar which he bough for a prostitute who left him for another man.

When I went to hire he told me he was going to charge me 5-10 dollars the most for my a divorce and for me that was a lot of money for a divorce but he told me that he was the best attorney and he guarantee me everything was going to be okay for me and my children he asked me for retainer fee. He continue to ask for more and more money because he says that the way its worked putting the money in an account and he was using the money for what he needs. He told me the divorce was going to take about 6 moths during this time he looks like he was all exited asking for more money.

He persistently requested to change judge because he doesn't like the judge because she was more sentimental he knew Judge he was very excited as me question about the houses and he say I can't wait to end this divorce so I can sit with you and talk about business. Also he offer my daughter a job well he call me a lot of times to his office and charges me 175 per hour to talk over and over same thing obviously to get more money our of me later he told me he was going to delay other 6 months more .

Why? I asked him he said that he felt that the case was not prepared. All the documents were ready because my daughter got everything ready for him and very prepared from the other 2 times my husband filed for the divorce. Like my husband said to get his 1/2 of properties now he yelled to me and laughs saying you hire this worthless attorney and even you paid him to give me everything, that's my husband exact words.

Back to in the deposition meeting he was really angry at me and started to treat me very rude. That day my husband told him the he was at our house and told me come with me to the next room then he told me is that true when I told him yes he got very very upset the turn red angry and since that day he stated to acting with me very rude and for any reason he call me to his office trying to talk to charge me more and more money. I didn't hire him to get jeoulus.

During the trial I was on the stand for two days, I was treated like a criminal and did not do anything to help just sat there. Bottom line is that my X husband has seven years not giving me a dime for anything. The rental were giving me minus every month repairs had to be made, insurances, utilities etc had to be paid. Having four growing kids is more difficult to be a single parent and raised them, kids are very expensive boys eat so much.

What was shouting of receiving 6000.00 a month well on paper looks good but in reality its not many factors to take into consideration vacancies, repairs, payments Sometimes you evict people and never see a dime and they destroy the place, I also did not charge the full amount of rent to some people like two set a seniors couples with not enough money to cover the rent, so yes I help them with rents and food. In addition to that taken advantage not only by tenants but by workers that would pretend to repair the problem and charge me for something they did not fix or repair.

All the time more of the time people take advantage from me and my daughter who was the only one to help me to manage these properties since she was 13years old started to cleaning and paint etc later when she turn 17 years old manage them then most of the time people destroy them leaving without paying the rent and when we asked my husband to help us to fix it he always saying yeah one of this days when I have a chance. So we ask for help to friends to help us because many of people rob us charging for parts they not even put to the coolers or other things tenant would break is easy for

figure on paper this what you got 6000 a month but she forgets the months apartments are empty destroyed or the big amounts I have to pay for taxes insurance repairs etc .I had to start the mortgages because we don't have any money to pay for the food cloths taxes car payments insurance including my husband truck payments, plates, insurance for him cloths electric bills water phone bills house cell phone for medicine gas for cars, since school was 35-45 minute drive from home (he was in a private school)

with her work buy vacant land and all this years she didn't get a single payment for property management she even transfer some on my bills to her credit cards besides we living from credit cards. Now why was properties included in the divorce if she worked and it was her money she paid with.

A day before the decision of this judge my attorney pass my house at and he saw my husband walking with me to the car and I see him he was driving in his silver jeep and he was talking in the cell phone looking at my house and I cannot be confused or nothing because he was the only car in that moment on the street why I ask myself he doing that because he took it personal and after in the court he doesn't do anything to defend me he was just sitting there eating his nails after the court he told me right there where went out of the elevators congratulations give me a hugh now you can build you can sell you can do what ever you want to do everything is yours then I ask him but don't you hear the judge say I have to wait 2 months I don't know why and he respond to me oh yeah is true but everything is going to be in your favor in two month later when the ruling came next day from him passing by my house he don't even pass by my house he don't even face me when my oldest children went to talk to him

went to talk to him he told them I don't what happen the only thing I know is the judge told him in order to the judge is going to have a higher posing in the court this was a very difficult case and this one was that case that why the y decided to give him everything and leaving me and my children in the street why if my husband admitted in there faces in court that he was an alcoholic, drug addict and he has another women and as not supported our family for 7years but he was paying the bills for the other women he was enjoying his life buying a jaguar car for this prostitute in the casinos and in rocky point, while my kids suffering why then this judge and this attorney decide to give him everything to my husband leaving me only my house which is mortgage no income at all no alimony or spousal support for taking care of my husband who was in drugs for years, leaving me without medical insurance and diabetes receiving child support for two teenager \$162.00 week for child support and only until is 16yeasr and is 18years which he turn this may why my ex. husband

enjoying the privilege this judge give him not to enforce to put medical insurance got him to put medical insurance for 13months ago because I tried several times to fill out the paper in the court and all what I receive from the judge where are the assets I respond to her you give him all the assets to

have incurred more than 10,000.00 in medical bills
