AFFIDAVIT OF COMPLAINT

AFFIDAVIT

I, _____, sui juris, hereafter "Affiant", having first hand knowledge of the facts stated herein, and being competent in mind and body to testify, declare and affirm that the facts stated herein are true, correct, and complete in all material fact, not misrepresented and made under the penalties of perjury of the laws of The United States of America and The State of Arizona.

1) This complaint is against _____ and
Officer, _____

2) _____ is in violation of numerous laws as well as Canons of Judicial Conduct, including but not limited to, Canons 5,6,9 and 18. _____ is also in violation of ARS. 11-424.02(A).

3) _____ has committed false arrest, felony imprisonment and kidnapping against me.

4) The unlawful saga of _____ and _____ began on or about _____. It was dark when _____ accosted me carrying a weapon (a loaded gun) and held me against my will for more than thirty minutes, not allowing me to leave to obtain a drink of water or go to the bathroom. He finally released me from being his captive about a half hour after he kidnapped me.

When he released me, he demanded that I sign a paper (Which I signed under threat, duress and coercion). Within the 72 hours allowed by law, I revoked my signature, in writing (via certified mail).

Then without any jurisdiction or authority, _____ began his reign of harassment and extortion against me.

5) Enclosed are some of the documents which I have filed with Court. Many of these have been filed more than 60 days _____ Thus far,

has ignored everything I have filed. has refused to act on any evidence which I have filed, and instead he has bull-dozed ahead with his own personal agenda of harassing me.

6) Because has refused to act on anything that I have filed, even the documents I have filed more than 60 days ago, has violated A.R.S.11-424, and according to A.R.S. 11-424.02(A), the penalty for his actions are that his paychecks (all compensations) are to be immediately terminated.

7) Both and work for the same corporation (STATE OF ARIZONA) and are both tax collectors for the same corporation; therefore, there is a conflict of interest in this alleged case.

8) I have already paid the extortion demand of \$520. via money order, but is not satisfied with that and he has given this extortion demand to a collection agency who now are demanding \$618.80. This makes the collection agency a co-conspirator in the extortion racket of and

9) I have learned through my own research that has caused the driver's license of to be suspended. He has done so without a Court Order and without valid jurisdiction. As agent for I, hereby demand that the suspension be immediately voided.

10) I have challenged the jurisdiction of on numerous occasions, and he has NEVER proven jurisdiction as required by Law. Instead, he has charged ahead with his own personal agenda without any Lawful authority or jurisdiction.

11) Enclosed is a Cashier's Check in the amount of \$520.00 payable to the ARIZONA SUPREME COURT and I hereby appoint the ARIZONA SUPREME COURT and it's Justices, personally, as Fiduciaries to disperse this \$520.00 to the various extortionists, including in the hopes that their harassment of me will cease. This is in full payment of all extortion demands made against me, and for settlement and closure.

12) in his actions of Trading with the Enemy, has failed to provide a remedy at Law.

13) By the silent acquiescence of he has proven that he is operating without a valid Bond or a valid Oath of Office.

14) I recently went to the Court and have looked through their file, and I noticed that after I filed the Writ of Mandamus, the court clerk sent a note to asking him what to do with the Writ and he sent a note back to the clerk stating "file it and ignore it". I asked for copies of those notes, but the lady at the

window refused, stating that this information was not for the public. Well, the court is "the public" and I am "private" so I should have been able to have a copy of that information in the file. If you will go look at that file before they cleanse it, you will find the same things.

15) I hereby demand that _____ and the officers of _____ be arrested and prosecuted to the fullest extent of the Law.

I further demand that the suspension of the license of _____ be immediately reversed.

I further demand that all compensation, including all paychecks, to _____ be immediately terminated.

I further demand that this false alleged case be dismissed "with prejudice" and that all further harassment of me immediately cease.

16) According to Law, the Arizona Attorney General is required to investigate and prosecute (_____) for their crimes against me.

17) If anyone wishes to bring any charges against me, _____, the Law requires that I be brought before an Article III Court and not the criminal Administrative business of _____.
