RE: Complaint Against a Judge

To Whom It May Concern:

At the end of the Arizona Commission on Judicial Conduct march, 2007 handbook, the last thing that you read is this:

Four things belong to a judge: to hear courteously; to answer wisely; to consider soberly; and to decide impartially.

I question whether or not these traits have been instilled in a Judge in my town. I wish to lodge a complaint against Honorable Pro Tempore

My reasons are as follows:

- A. The Court issued an Order of Protection on my behalf. The Defendant, forced his way into our home on that date.
- B. said Order was amended due to contact from the Defendants girlfriend via regular mail.
- C. I was served with documentation from the Defendants Attorney, In that document, counsel requested that the Order of Protection be moved to and be consolidated with out Family Court Case
- D. I submitted a letter to the Court as to why I disagreed with this request.

E. I was advised via regular mail by the Court that this case had been moved to per an Order signed by Judge

F. I composed another letter to the court and questioned this transfer as I was not given any right to be heard. Upon hand delivery of this document to the Court, I was advised by the Clerks at the counter that the case had been transferred, they had no information on the case any longer and that they would not accept my letter to Judge with regard to the case and the conduct of Judge

The behavior by Judge is unacceptable. She offered no reasoning for her decision (neither did the Attorney requesting said transfer) and did not allow me any opportunity to be heard. In fact, while disputing the transfer at the Court the Clerks in said office seemed also confused about the reasoning behind the transfer. I am the victim in this case. I deserve the right to state my case and to be heard. This Order of Protection does not in any way have anything to do with our family court case and in fact should remain in the Court, especially while the Defendant is being prosecuted by the State of Arizona, for felony trespassing and misdemeanor disorderly conduct.

The Defendant in this case barged into my home, frightened me and my children and I do not, for the life of me, understand how a Judge can move such an important case to a county in which the Plaintiff, her children and her family do not even live AND MORE IMPORTANTLY do so without talking to me at all. No hearing was awarded and I am under the impression that the Defendant has the right to a hearing to state his case. This did not happen. Instead, his crooked attorney manipulated the system by having her Judge friend toss my case to another county.

In addition, the time frame for this transfer makes no sense whatsoever. I was given NO OPPORTUNITY to respond. I was served with the request on the 18th (a Monday), I responded with a letter on the 21st (a Thursday) and the decision had been made by the Judge to transfer the case on the 20th. Unacceptable.

I hereby request that this committee look into this issue and reprimand Judge appropriately. I also intend to file a complaint against Attorney for her actions, as well as additional unprofessional, manipulative actions that she has been a part of. I question her relationship with this Judge. We live in a small town and I would assume that we would all be treated fairly. I do not believe that I was given that opportunity.

I look forward to hearing from you with regard to a resolution on this issue.
