Over the last few years my wife and I have experienced what can only be described as being the decay and crisis, of the judicial system in Arizona (America). I find it laughable that "Judge" Arizona is actually considered competent to hold a position as Judge.

Our vehicle was illegally repossessed by [redacted] at my wife's employer's parking area [redacted] After sold this car at an auction for \$2,500.00 and applied this amount to the balance we "owed", [redacted] ignored the new balance of \$4,500 we owed and entered judgment for \$12,000.00 another \$7,500 more than we owed according to documentation. [redacted] had placed a garnishment on my wife's wages, and the remainder \$4,500.00 balance is accomplished. [redacted] has shown complicity, ignoring courtroom documents that portray [redacted] perpetration of fraud upon his court. When we sent our informative response to the court we found that we had been judged against due to us not paying a \$24.00 dollar answer fee that we never knew about until after [redacted] had made judgment. [redacted] had employees stalk my wife and myself at our home and at our workplace's after we had moved This is a testament to their greed and their unethical business practices.

I responded to a subpoena to appear in court. This was the first time I had been to a courtroom for this matter. Just prior to my court time [redacted] pm a gentleman was waiting for a traffic violation court appearance. The court was waiting for the [redacted] Law Enforcement Officer to show. [redacted] announced that he had a fifteen-minute courtroom appearance policy and that if the officer did not arrive within that window he would dismiss the case. At the time for my case to start, [redacted] fifteen-minute courtroom appearance policy came and went. [redacted] never showed. [redacted] announced that [redacted] must have forgotten their court appearance time, and said that we could have the court clerk telephone [redacted] to the auto dealership to get someone to appear for court. I did not agree with him, as I had driven several miles and was 30 minutes early for court, [redacted] Not even 30 minutes earlier [redacted] had dismissed the traffic violation for a no show. It seems there is one time frame policy for the [redacted] police department and an entirely different policy that caters to having the court clerk call and remind [redacted] to come to court. Perhaps there are policies for Native Americans, Blacks, and Jewish people too? [redacted] asked if I had any questions. I

did. I still do. I asked him why he found judgment for us to pay over twice the amount that we actually "owed" I showed him the document sent me with the remaining balance of \$4,500.00 He looked at the document and said nothing. He asked if I had any further questions, I did and I told him had we known about a \$24.00 answer fee we would have sent it with our answer, and this would have prevented us from paying \$12,000.00. I asked several questions and presented the documentation. I sincerely hope that the State of Arizona Attorney Generals Office has the responsiveness and awareness to question even and their ruinous repulsive business practices.
