CERTIFICATE OF EXECUTION HAS NEVER BEEN FILLED OUT BY THE ARRESTING OFFICER  
STATING WHAT TIME I WAS ARRESTED. NOR WAS IT RETURNED TO THE JUSTICE COURT  
TO BE FILED WITH THE ORIGINAL AS REQUIRED BY A.R.S. I CALLED  
JUSTICE COURT REGARDING THIS WARRANT AND THEY TOLD ME THEY DON'T DO FELONIE  
OR ISSUE FELONY WARRANTS. THEN WHY ARE THEY TAKING FELONY COMPLAINTS AND  
PUTTING FELONY CASE NUMBERS AND CHARGES ON MISDEMEANOR ARREST  
WARRANTS? I FEEL THIS JUDGE IS OVER STEPPING HIS JUDICIAL DUTIES AND HIS  
AUTHORITY OF OFFICE. I WAS INJURED OVER THIS WARRANT THAT WAS ISSUED BY  
HIS HAND. I'VE ENCLOSED NOT ONLY THE WARRANT ISSUED FROM  
HIS COURT, BUT A PAGE FROM MY POLICE REPORT BOTTOM PAGE  
LOOK AT WARRANT INFORMATION DETECTIVE AND DETECTIVE  
CONTACTED THE COUNTY ATTORNEY'S OFFICE TO  
REQUEST AN ACTIVE WARRANT FOR MY ARREST. THE REQUEST WAS GRANTED AND  
A FELONY WARRANT WAS ISSUED WITH A 50,000 BOND. THE WARRANT I  
ENCLOSED IS A MISDEMEANOR ARREST WARRANT WITH A 50,000 BOND, A  
FELONY CASE NUMBER AND FELONY CHARGES. IF THE JUSTICE COURT DON'T  
DO FELONIES, WHY WOULD THEY ISSUE A WARRANT LIKE THIS, I WAS ALMOST  
KILLED, I WAS INJURED BY ~~SEVERAL~~ MULTIPLE TASK FORCES. I WAS TAZZERED  
AND SCARED AND BURNED ON MY PRIVATES. THAT'S DOCUMENTED HERE AT  
THE JAIL. THIS WARRANT NEEDS INVESTIGATED.
