I have been backdoored into paying child support for my wife's child from another relationship by \_\_\_\_\_. The report that was prepared for the court reflected what each parent could pay. The report reflected that my wife couldn't afford anything. My wife has four other children in the home. Of the four children only one is my birth child however I take care of all of them as my own. These four children doesn't include the child between \_\_\_\_\_ and \_\_\_\_\_ has backdoored me to the point where she has pinned me against the wall. \_\_\_\_\_ has and continues to cause me harm. I have had enough of her abuse of authority.

My name is [redacted] I am the husband to [redacted] and [redacted]. The following statement is to defend myself from the abuse of authority by [redacted] uses her discretionary authority to backdoor me into paying child support for a child from a previous relationship between [redacted] my wife and [redacted]

[redacted] is a Family Law Commissioner in [redacted] Arizona.

My wife is a at home mother of four children their ages range from 21 months to 16 years! This is a 24 hour a day job and a seven day a week job. These children don't include the child between [redacted] in the above action. I would like to believe anyone with any common sense would agree that at best this is four full time jobs. My wife goes from 0600 hrs to 2100 to 2300 hrs everyday taking care of the children and the home. (Note) [redacted] is aware that [redacted] has these additional children at home and can't work out side the home. If [redacted] and [redacted] had their way she would work the remaining time to pay him. Our children are fortunate to have a stay at home mother and that includes [redacted] when he is here. The jails are full of individuals that came from homes where both parents had to work. Our children have and deserve a mom to wake up to and go to bed with every day. A lot of children today don't have this. If anyone has bothered to check the quality and cost of child care lately you should understand this it's not great and it's not cheap.

[redacted] only has a 9<sup>th</sup> grade education so at best she could only make 7.50 to 8.00 dollars per hour. I would hope someone over there could do the math but once you subtract child care she would be in the hole. Because [redacted] is married to me she can't get any state or private assistance for child care. I am sure [redacted] answer to that would be [redacted] can pay it. I have no doubt that if giving the opportunity [redacted] would backdoor me here to.

A report was prepared by the court to reflect what each parent could afford to pay for the child between [redacted]. The report on [redacted] reflected that she couldn't afford to pay anything. [redacted] just went around this altogether once [redacted] spoke up and told that [redacted] drives around in a 60 thousand dollar vehicle and lives in a 600 thousand dollar home that is when [redacted] decided [redacted] could afford to pay child support and the arrears and insurance. [redacted] also felt the need to bring up my children and my wife's cell phones and my wife's finger nails. **(Let me make it very clear what I do with my money is my business and not [redacted])** {(Note) [redacted] was aware at that time that the money and assets were not [redacted] } that is when [redacted] went around the Arizona Revised statutes that prevent a spouse from having to pay their spouses child support from a previous relationship. [redacted] did this to get [redacted] his child support. [redacted] ordered [redacted] to pay 240.52 dollars a month or I should say ordered [redacted] to pay 240.52 a month. For your information [redacted] doesn't know what the bills are and when they are paid and that includes the child support. In your open court [redacted] stated that [redacted] ran up large bills and then paid them I can tell you that is not true. [redacted] the truth be known there is a lot of things that have been told to you in open court about my finances by [redacted] that are not true. The reason [redacted] is wrong is because he got it from [redacted] and she don't know ether.

What [redacted] didn't know and wouldn't listen to in open court or maybe she did know and just didn't care was that the homes the cars and money were mine and solely mine and that [redacted] name isn't on anything. They were mine before [redacted] and I was even married. My wife is not on any of my accounts and has no control over my money and no access to my assets. [redacted] has no assets of her own and no means of support other than me. I would like to mention that 3 of the 4 children in are home are not mine by birth but I take care of them as my own. When [redacted] is here at are home he is treated the same as all the children. [redacted] is the child between [redacted]

I didn't find it very funny when [redacted] in open court stated that it seem that every time [redacted] was faced with jail she could come up with the money to pay to keep herself out of jail. For [redacted] information I was the one paying it and once again [redacted] backdoored me to get the support. For your information [redacted] I paid [redacted] father back his 600 dollars that she borrowed to pay you your blood money. [redacted] also stated that if [redacted] missed any of the next twelve child support payments she would put her in jail. I find it despicable that a judge would use a threat of jail when the individual being threatened has no control over whether it will get paid or not or has no income. [redacted] just so you know it wasn't and isn't [redacted] that has contempt for you child support order she fears you it is me. I just want to make it clear that I don't have just have contempt but I have vile contempt for your child support order you have no right to backdoor me to get what you want.

What upsets me is no one bothers to watch [redacted] at all; it seems she does what she wants when she wants. [redacted] I am not going to be your whipping boy any.

It appears to me that [redacted] thinks that because she has that black robe on and sits on that bench so she can make my wife feel little and like dirt in front of [redacted] Let's remember are world history for a moment here. Wasn't it the mighty SS who used these tactics to get what they wanted? The only difference I see here is they used a pistol and pen was used here. But this is just my personal opinion.

For [redacted] information it wasn't my wife refusing to pay her court ordered child support it was me. I didn't like being backdoored by her to pay it then or now! It would seem to me if [redacted] would run her court room instead of letting [redacted] do it some of this could have been avoided. I found it appalling that in open court [redacted] ask [redacted] if he wanted to go ahead and proceed with the contempt or not who is running [redacted] court.

It seems to me that since [redacted] has backdoored me from the very beginning to get this child support I think [redacted] owes me my money. I mean all the money right down to the cost of the money orders but this is a fight for another day.

It also appears to me that the [redacted] attorney's office of the child support division completely dropped the ball. It would seem to me that [redacted] should have brought it to [redacted] attention that [redacted] was backdooring me. It appears to me that they are not interested in upholding the law but just collecting what ever they can rather it is legal to do so or not.

I have no doubt that [redacted] is going to retaliate against my wife for my writing this complaint. I don't believe my wife or I at this point will be treated fairly by [redacted] Superior Court. I expect [redacted] to do what ever she can to make are life miserable but it will not work.

I have in an attempt to make [redacted] happy I have gotten rid of the big house and moved my family back to [redacted] so that takes care of the 600 thousand dollar home. I sold the 60 thousand dollar vehicle so that is taken care of.

I have thinned out most of the amenities that [redacted] has complained to [redacted] about. If there is anything else [redacted] you would like me to get rid of so you will stop backdooring me please let me know.

It is apparent to me that [redacted] is going to keep backdooring me until someone in Superior Court stops her or the Arizona Supreme Court. I don't have anymore money to pay this backdoored child support or the arrears or the insurance. (Note) It is not [redacted] or anyone's business at the Superior Court of [redacted] how much money I have or what my assets are. I would have nothing to do with this case [redacted] had to backdoored me. If I want to hire an attorney with my money for my wife it is my business. It would seem that [redacted] thinks if my wife can afford an attorney then she can afford child support. [redacted] information I pay for her attorney.

I will see if this complaint gets me any Justice in [redacted].
