To whom it may concern, I am in the middle of a divorce and custody suit. My first hearing was in Aug 08 to establish temporary custody of my ~~male~~ child.

Age 2 at the time. We came out of a very abusive relationship and I filed for supervised visitation and mandatory drug testing. I was belittled ~~at~~ by his attorney and the judge numerous times. I brought in proof about everything, so that it wouldn't be hearsay. I had brought in my husband's AA 12 step paper because he had admitted in his own hand writing that he has physically and verbally abused his children and ~~and~~ he admitted his drug and alcohol addictions. His sexual abuse to me. I had also brought in tapes I had recorded of him on the phone and visits we shared with our minor son. He admitted chasing his children with a closet pole, breaking things in the house, throwing his son ~~across the room~~ which seem to happen frequently. I had another tape that he said "if I didn't get over there and get ~~something~~ bad was going to happen." My attorney on my behalf was asking for supervised visits, drug-alcohol counseling and testing

I have never felt so humiliated or belittled in my life. I had a lot of evidence and still no one would listen to me. \_\_\_\_\_ sat right there and

said he didnt blame me for having fear. As a result my son still goes over there twice a week. I have put a recorder in my sons diaper bag every visit. Nothing has changed he is still very verbally, emotionally and physically abusive. I have contacted cps they went to check on his children they both deny it. They are both teenagers and have no rules ect. "cps" -> they say they believe me but until the kids tell the truth or some one gets a broken bone or bruises then they cant help me.
