I felt it was unfair and sneaky to not give
me at least 24 hrs notice to work out other plans
with work, I already scheduled off work for the
next day to appear to a court ordered "Parent
Conciliation" With the little time I had to get
from _____ to _____ in a short time to ~~try~~ try
and dismiss or squash the verdict that has
been placed. It was too late, Judge already
ruled and favored to the Defendant's Lawyer.
I strongly believe that
if the meeting would have presumed, ~~that~~ my
ex husband, the Defendant, did not finish or didn't
do what was court ordered by the same Judge,

"parenting plan" that was suppose to be done 5yrs.
prior or at least proven to the court that he
completed a class. I feel the Judge & lawyer
pulled some strings that I could not stop nor object.
