Attached you will find Motions filed with the _____ Municipal court the timeline of events by Exhibit "B" of the hell originating from these Attorneys named above.

In an admission of his own by Assistant _____ to me as the Mother of _____ being held in _____ as I write this complaint, _____ said that _____ has fallen through the cracks!

Let's see how would one act as a Mother? Those words keep rolling through my head over and over again every sleepless night that I lay awake.

The way the Town of _____, the named above act and have never been investigated is unreal to a human brain. By a notice that was never given out, never summoned to court for a hearing, a hearing date unknown, these named people have a Judge of the Court issue a warrant for non-appearance. A Judge actually then is used to start the future and further damage to an individual, now my son. I've had three different stories from 3 different clerks of the office in the Town of _____ all of which make no sense to me at all. These named Judges actually uphold the wrongfulness of these Prosecutors in belief of their lies and decite.

Knowing the truth of the matter and falling in the cracks to begin with there was never a ticket signed, never a notice given, an unknown wrongful hearing was set with my son tagged to it; warrant was issued on 5-27-09; 12 days after this make-believe hearing; driver's license was suspended and sent to the RIGHT address and my son sits in the jail with an ongoing issue with Town of _____

The Prosecutors knowing what they did FAILED and let my son FALL THROUGH THE CRACKS of their system; a constitution written and only understood by them; since June 2, 2009 until I called and made connection with

When does anyone see this, hear this or act on it.....

And guess what it happens all the time especially to our young men of this community.

Furthermore Police Department and Town of are still acting out against us by the retaliation whenever they can from the Civil Case that we have pending against them with Judge of the Superior Court.

These people constantly attack us when they can from their fault of an attack in 2007 in front of our home. The cops follow us, write tickets when they can, file erroneous documents such as this, issue warrants against my son; its totally amazing.

This is happening to many many people; does anyone hear and when can an investigation be done?

It is now June 15, 2009; my son, has been sitting waiting for word from the Town of since June 2, 2009. It has now been 13 days of wrongful incarceration by the Prosecutors and Judge of the Town of

While now under this extreme duress, after 24 dismissed cases in court and over 40 cases in Superior Court, my son, is suffering post traumatic mental disorder, feeling helpless and alone while the Town of is still to this minute wollering in their retaliation against him and the rest of our family knowing that this is also mental anguish to his little girl, age 3, that he cares and nutures 7 days a week and to me his Mother.

HITLER died but I do believe his SPIRIT lives in the Town of

This is an attachment made a part hereof to the complaints hand delivered to the AZ State Bar Association and to the Arizona Judicial Review Board while my son cannot communicate to you and I do this on his behalf and for the sanity and safety of our family while trying to survive in Arizona.

Our family begs for a way to live peacefully and without harm and wish that one in your organization would take charge of the oath given as a sworn Attorney for the State of to charge, penalize, investigate, damage and make surrender in whole their jurisdiction, employment, authority, license and/or all control, not in part, these known offenders of the law in which they are to abide by, ATTORNEY AND ATTORNEY while prosecuting and victimizing the innocent, for the past and ongoing prosecution of my son's life, past, present and future, DOB 10-21-83 IMMEDIATELY.
