After speaking with the two attorneys in chambers, Judge _____ goes on the record and tells me "my hair could be considered "Oak", "The Victim can not I.D me" My seminal fluid was found on the outside unenclosed apartment patio on March 05 after 10 months of incarceration I finally go to the police records (exhibit 1) where the Assailant as Mexican, I am white (Exhibit 2) Originally I thought _____ and _____ deceived Judge _____ which is why he represent the case "in all fairness, honesty and integrity" as he did, so I filed complaints with the Arizona State Bar (Exhibits 3, 3A) but as you can see the State Bar concluded they did no wrong, so that only leaves Judge _____ who uses his acquired prestige and Integrity to try and deceive me about the case against me.
