Sir or Madam,

After receiving information that the "JP" was not living in his precinct I took time to go to the address given by the Maricopa County Elections Department when appointed him. This is an older home with curtains made of sheets drooping and cardboard in and on the windows. After reviewing "public records" I learned that the appointed JP had given a forwarding address of [REDACTED] in Glendale Arizona. This came from the Maricopa County Records office. It states that he [REDACTED] assigned this property at [REDACTED] and rights to [REDACTED] properties LLC. Meaning that he gave all rights and interest to this company July 20th 2006 and forwarding address of [REDACTED] az. Further this is notarized and filed in a Government entity; by doing this he is willfully un-truthful and would be a felony for filing a false document to secure employment (voter registration also). It does not take a mathematician that he has been at the Glendale address for at least (3) three years. Public records show a phone number of [REDACTED] in the name of [REDACTED] at the Glendale address. Other public documents show that as far back as 1-26-1993 he had the address in Glendale. This was also notarized and filed with a government entity. This is called "Fraud in securing appointment" this willful misrepresentation and omission that

affected the selection of the appointed position of Justice of the Peace by _____ Which _____ had knowledge and could have checked his claims of residency, that he _____ was not living at the address of _____ since the appointed “JP” has filed and swore that the facts were true in a government entity (records office). He has failed to change his address on his driver’s license since 2006, which is a violation of law. This is documentation that shows that he willfully violated the “Oath of Office” that _____ appointed him to. It also shows that _____ abused her powers to secure a “friend” employment with Maricopa County.
