I WAS NOT ARRESTED FOR A DUI there is NO WAY my FINGERPRINTS could match so I ASKED the clerk what I could do she told me I could write the court AND request AN Identity hearing I did so on 7/15/09 at the SAME time I requested that A public defender be appointed to me before I go out there to try AND RESOLVE this matter.
