MOTION, I UNDERSTAND BUT FROM THAT POINT ON SHE HAS BEEN VERY RUDE
AND PREJUDICE TOWARD ME. MAYBE BECAUSE I DON'T EXCEPT
THE PLEA OFFER, IF I TAKE IT TO 15 YEARS AND SHE GOES TO GIVE ME 10 YEARS
THAT WAS IN APRIL OR MAY THEN I REMOTION FOR CHANGE OF COUNSEL AGAIN IN APRIL
AND THE JUDGE WOULD NOT EVER RE- THE MOTION, SO I FILED AGAIN IN JUNE
AND SHE WAS BRINGING TO HER THE MOTION UNTIL I MADE A DEAL WITH THE
PUBLIC DEFENDER, AND HE TOLD HER ON RECORD SHE DID NOT REVIEW IT, SHE

RELEASED BACK OUT ON BOND (HERE'S PROFF) THIS 2009 CASE SHOULD BE DISMISSED
