- ⑥ 9 APRIL 2009 I ASKED "DID YOU JUST ATTEND A SECRET MEETING, BEHIND CLOSED DOORS?" HE SAID, "YES." WAS
IN THAT MEETING?
- ⑦ IN OWN WORDS, "IT IS ORDERED THAT THE PUBLIC DEFENDER'S OFFICE IS WITHDRAWN FROM FURTHER REPRESENTATION OF THE DEFENDANT IN THIS MATTER."
- ⑧ CHANGED HEARING DATES WITHOUT LAWFUL NOTICE TO ME. MATTER OF PUBLIC RECORD
- ⑨ SAID, "WHERE ARE YOU LIVING?" "I'M LIVING OUT IN THE DESERT." "I ASSUME YOU'LL BE THERE UNTIL DECEMBER." I OBJECTED TO HIS THREATENING USE OF THE WORD "ASSUME."
