WHEN RESEARCHING THE RECORDS FOR FEATHER ON THE MESA, WE FOUND A DISSOLVED CORPORATION, FEATHER ON THE MESA, INC. AND (HON.)

WAS INDICATED AS THE STATUTORY AGENT FOR THE DISSOLVED CORPORATION. IS THIS LEGAL? I CAN NOT BELIEVE THAT HE DID NOT REMEMBER HE WAS THE STATUTORY AGENT FOR FEATHER ON THE MESA, INC. OR

THEY ARE VERY DISTINCT NAMES.

IF I FAILED TO NAME THE LEGAL ENTITY AND I FIND A DISSOLVED ENTITY OF FEATHER ON THE MESA, INC....DO I FILE ON THE DISSOLVED ENTITY OR DBA FEATHER ON THE MESA. IT SEEMS TO ME THAT I DID NAME THE LEGAL ENTITY IN MORE WAYS THAN ONE.
