This Judge laughed at me and demeaned me in the hearing on 10-2-08 and if I come back he will make things worse for me. This Judge has allowed a very aggressive attorney to continue keeping the focus off my child. I have been at the mercy of this attorney since 2003 along with my exhusband, who set me up to lose all rights - Constitutional Rights to have a relationship with my 16yo. daughter whom I've only seen once in over 2 years. This judge never bothered to ask my exhusband if he did hit me during marriage, he never bothered to ask about the proof & documents I repeatedly sought to submit & finally did submit to him for the 10-2-08 hearing. This Judge has allowed opposing counsel to financially devastate me again & perpetuate baseless allegations that have forced me to pay over 26,000⁰⁰ defending myself, causing bankruptcy while I was recovering from a tax lien my exhusband caused. The IRS transferred that tax ^{lien} to my exhusband's social security number ^{in 2003}, he swore he'd get even. My exhusband is the same man that swore to a paternity judge he wasn't dad. Now this judge has allowed my exhusband to continue kidnapping my daughter from me while he can take off & go gambling & partying in other states & Arizona has no clue what's happening to my child. Why didn't the judge look at my exhusband's face when I told him I was beaten. I have the MRI & XAYS to prove it.

Why doesn't this Judge care about my daughter's pattern of absences and plummeting grades? Why aren't there any questions asked of my ex-husband by this Judge? Why does this Judge show favoritism to opposing counsel who offered DUI cases to my attorney for helping her so much, he was so grateful he walked her out. My attorney was still laughing after the hearing. I have an e-mail between my last attorney and myself and I am now convinced this Judge doesn't care if I never see my child again. It may be funny to him but I have been grieving for a long time. This Judge has fixed it so my ex-husband could move to a remote, expensive location in the mountains, while claiming to this court he makes very little money. This Judge has allowed this court to keep a child out of state, keep jurisdiction, bury the petitioner in costs and threaten her with jail. There are two people in the courts system that do know what's really going on and that's my first attorney who I lost thru bankruptcy and being accused of Munchausen's Syndrome by Proxy and Judge , who did have serious questions about the validity of the multiple accusations against me. My ex-husband was caught lying to Judge about his income which showed higher in a tax evaluation I had to pay 2,200.00 for. There are some serious medical issues going on for my daughter that my ex-husband is deliberately neglecting. To the point that my daughter was forced thru root canal surgery right when school began, when my ex-husband previously agreed to continue orthodontic work . Dr. repeatedly lied to by my ex-husband who at one point was on the road to Nevada to gamble while there were e-mail discussions going on. Not only does my ex-husband extensively lie to Judges but so does his counsel who told a previous judge that the knife my daughter brought to school was an academic tool. I have extensive evidence of being set up but each of my new attorneys have been intimidated by new accusations, being buried in paperwork and my inability to pay out more money after the retainers were paid. This Judge has fixed it so that I have no chance of seeing my daughter again and his partiality toward a young pretty attorney is devastating to my daughter and myself. WHY does this Judge keep jurisdiction over my child who was sent away 5 years ago by this court. Even though I proved I don't have Munchausen's Syndrome by Proxy this court has made it very easy for an attorney to destroy someone they don't even know. Right now my daughter's living in the mountains where the fires are and my ex-husband can be mean to her and slap her as he has in the past and he has full control. This Judge has not done my daughter any favors and he's buried me financially so that I can't recover. It really hurts to see a Judge lean to one side so much and be so wrong. I'm sorry I ever came to the courts for help, I've had a restraining order on my ex-husband in the past and had to stay in a battered women's shelter, lost my housing four times and had to rely on my siblings to get back on my feet. All caused by my ex-husband who now has sole custody based on allegations that keep surfacing against me and making opposing counsel quite rich while my daughters future is looking dimmer all the time.
